ONLY ENTRIES WHICH CONFORM TO THESE CONDITIONS WILL BE ACCEPTED.

# **GENERAL CONDITIONS**

1. Eligibility

a) **General** - Entries will be accepted only from residents of the Serpentine-Jarrahdale Shire or those children attending a school within the Serpentine-Jarrahdale Shire. Group entries will be accepted.

b) Youth Section - Subject to the above, entry is open to all community members who are aged 11 - 19 years at the date of judging.

# 2. A maximum of TWO entries may be submitted from any one Exhibitor.

3. The greatest care will be taken with entries but The SJCRC accepts no responsibility for loss or damage. The SJCRC and anyone working or doing volunteer work for the SJCRC for the duration of the SJ Community Fair is under no obligation or liability. This includes the loss or damage occasioned to, or by, any property exhibited, whether caused by or attributed to the negligence of the SJCRC or its servant or agents or otherwise howsoever. It is recommended that the Exhibitor arrange appropriate 'all risks' insurance.

4. All entries must have been completed by the entrant.

5. The sale of Exhibits is optional. Artworks not for sale must be marked 'NFS' on the art work label.

 No entry which has received an acceptance in a previous SJ Community Fair competition (or which in the opinion of the Director is substantially the same as any such entry) is eligible for entry.
Any entry that may cause damage to any other entry or to the organiser's equipment will be rejected.

8. No refund will be made for any rejected prints.

9. The Selection Panel has full discretionary powers to make awards in all Classes.

10. Permission to reproduce entries to promote the exhibition is assumed unless otherwise advised.

11. Any entry considered by the Director to be unsuitable for the exhibition will be rejected.

12. All entries must be appropriately titled for identification E.g. Untitled or Untitled #1 is NOT acceptable.

### ARTWORK FRAMING, HANGING AND SIZE REQUIREMENTS

13. All artwork should be mounted or framed for best presentation. If you need assistance with framing and mounting please contact Nino Coniglio – 9526 2251 or 0400 057 041.

14. All artwork must not exceed 120cm x 120cm x 19cm depth including any attachment format of framing, nor exceed 15kg in overall weight.

#### SALE OF ARTWORK

15. The sale of exhibits is optional. Artworks not for sale must be marked 'NFS' on the back of the artwork.

16. The SJ CRC encourages the sales of artworks while the exhibition is in progress. A commission of 15% (inclusive of GST) is charged by the SJ CRC on the sale price for all artworks sold during the exhibition. If the artist is registered for GST, the commission is levied on the sale price inclusive of GST. Payment for paintings sold will be remitted AFTER the exhibition.

#### ENTRY FEES

17. 11- 12 years old – FREE ENTRY 13-19 years old ENTRY FEES ARE \$5 PER ENTRY.

Suitable return post bag and postage or details of preferred courier company must be supplied. If using a courier company account details must be supplied by entrant.

18. Artists who are unable to deliver or pick up their artwork and intend to use an agent must supply in advance a signed letter of authority which includes the name, address, signature and contact numbers of their agent.

19. ENTRY FORMS AND FEES (if applicable) MUST BE RECEIVED AT THE OFFICE BY NO LATER THAN FRIDAY, 17TH JULY 2015.

#### **DELIVERY AND COLLECTION OF EXHIBITS**

20. Exhibits must be <u>delivered or received</u> to the SJ CRC at 2 Paterson St, Mundijong, WA 6123, between Monday, 27<sup>th</sup> – Friday, 31<sup>st</sup> July 2015. Office hours 9am – 5pm.

21. Exhibits can be picked up from Monday, 17<sup>th</sup> August 2015 from 9am and must be collected by 5pm Friday, 28<sup>th</sup> August 2015. Office hours are Mon-Fri 9am-5pm.

22. The SJ CRC will issue a receipt to the artist or their agent upon delivery of the exhibit. This receipt must be shown at all times for the handling of the artwork including removal from the exhibition, if not sold.

23. The SJ CRC has no facilities for long term storage and will not be responsible for any exhibits not collected within 30 days from the day of the Exhibition. Therefore the SJ CRC reserves the right to dispose of as they see fit, any exhibit not collected by the specified date.

#### **EXHIBITION**

24. The exhibition will be judged prior to Thursday, 13<sup>th</sup> August 2015 (exhibition closed during judging) and then on display Friday, 14<sup>th</sup> August 2014 at the Exhibition Sundowner from 5pm and during the 2015 SJ Community Fair Saturday, 15th August 2014 9am til 4pm at the Serpentine Jarrahdale Community Resource Centre – Function Room.

#### **COPYRIGHT AND MEDIA AGREEMENT**

25. Copyright remains the property of the artist however, by signing the Entry Form it is agreed that artist clears Copyright to the SJ CRC, and gives permission for the SJ CRC to use images and reproduction as needed for media purposes. This will cover the two year period following the 2015 Exhibition.
